SUBJECT: **SEPA LEAD AGENCY & DETERMINATION OF NONSIGNIFICANCE**

This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Stilly Revisited Timber Sale #93860 and Forest Practice Application #2819253 proposal is a variable retention timber harvest of 7,930 MBF on approximately 152.1 acres. The proposal includes approximately 4,280 feet of road construction, 2,614 feet of road reconstruction, up to 1,406 feet of temporary road construction (road to be abandoned after completion of use, if built), and 23,890 feet of pre-haul maintenance. Located in Sections 03, 04, 05, 06, Township 32 North, Range 06 East, and Sections 01, 12, Township 32 North, Range 05 East, W.M., Snohomish County.
