This harvest unit is 40.7 acres in size. Slopes vary from flat to rolling, to steep with some unstable features. This area will be clear-cut harvests in 2024. Road construction outside of harvest unit will take place before harvesting has started. Installation of culverts, ditches and silt traps to minimize impact for further activity of DSL.

Yes, there are signs of activity within the mapped DSL on the geotechnical report. Sagging and cracking were discovered along several parts of the road. At the south end of the Project area, a recent failure exposing fresh soils on the head/side scarp of the larger DSL feature was present adjacent the west side of the road.

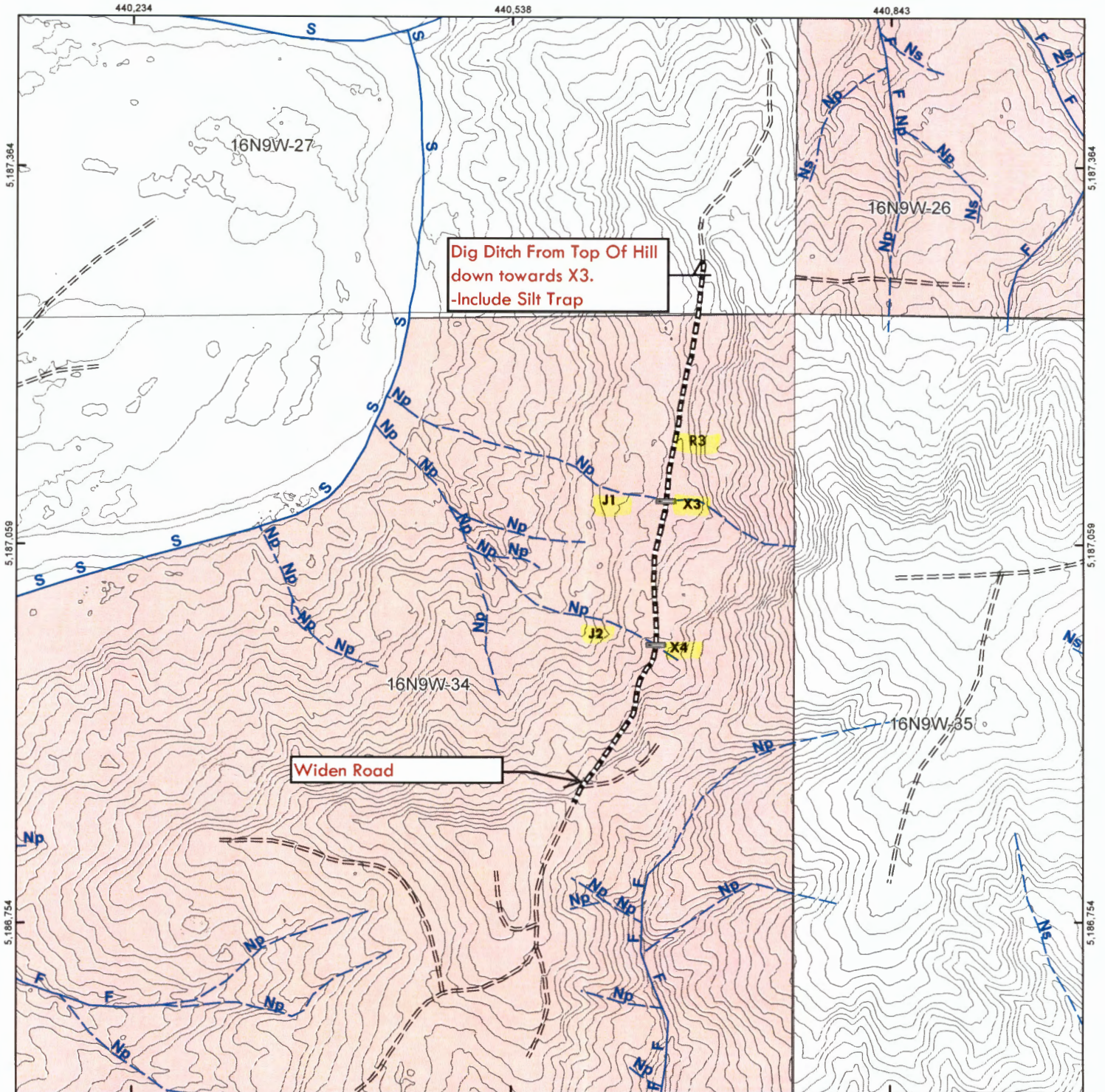


HAMMER WEST FPA MAP #2
