Science Session

♦ 2015 CMER Work Plan – *Approval* - **Approved**

Mark Hicks requested approval of the 2015 CMER Work Plan. Doug Martin commented that the Wetlands section did not accurately reflect the changes that were agreed to by WetSAG and brought to the January meeting. Mark replied that he believed he had incorporated the changes presented and agreed to at the December meeting, but that he would just change the Wetlands section to match the original changes proposed by WetSAG so we could move on. Mark then asked Patti Shramek to send him a copy of the original WetSAG proposed changes so he could make sure the revisions matched.

- ♦ Buffer Integrity Shade Effectiveness (Amphibian) Budget Request Approved Amy Kurtenbach requested \$5,800 out of the CMER project development fund to cover PI time to respond to CMER reviewer issues with ISPR comment response.
