Science Session:

Wetland Mapping Tool

Amy Yahnke gave the background of the project that Ecology is working on (National Wetlands Inventory Layer). She reported that it is extremely out of date (30ish years). The Washington layer is miss-represented and they are working on updating it. The Ecology project (funded by the EPA) ends in June 2018.

Luke Rogers presented the technical aspects of the mapping tool and explained how what Ecology is doing fits into it.

Presentation on Phase I

Debbie Kay explained that the mid-year project last year was to feed data into the open-source tool with UW to help obtain better data of wetlands.

Overview of subsequent phases with a description including budget and schedule.

Kay reported that the data has been gathered and is ready to hand off to a third-party vendor to develop the tool. Once the tool is developed it goes back to UW to complete. Rogers explained all that UW did to get the project to this point. Kay, Rogers, and Yahnke answered questions.

Kay explained that it might be able to help find Wetlands for future projects. Yahnke remarked that this could augment the National Wetlands Inventory and could help local jurisdiction management and the volunteer stewardship program.

Chris Mendoza remarked that he would like CMER to have a larger discussion in the future regarding having long term funding (Master Project Schedule) for "mid-year" projects that extend beyond a single fiscal year. Having larger mid-year projects limp along year to year in hopes of taking advantage of CMER unspent funds, in this case to develop a rule tool, is not feasible.

SAGE

*Fire Salvage Literature Review – request for funding

Angela Johnson gave background on the request and asked for approval.

Martin asked what they hope to discover with this literature review and what they plan to do with it. He remarked that a report was just released by PNWCG that has a part that addresses this. He asked for some investigation on what is already out there. He suggests partnering with PNWCG in this effort. A.J. Kroll said he agreed with Martin and also thought the questions in the request were too specific. Mendoza replied that he thought the points were valid, but the literature review will call out where there is a lot of information and where there are gaps. He also pointed out that CMER had ranked this as number three in the fiscal 2016 mid-term project ranking, after the Wetland Mapping and the Timber Habitat projects. Hans Berge agreed with Kroll that the questions were too specific and recommended that SAGE broaden the scope. He also agreed with Mendoza on the project ranking. Hicks remarked that the questions are so specific because SAGE has the experience and knows where there are gaps. Kroll remarked contacting people that have already done similar work to help cut the costs. Hooks remarked that he thinks it needs to be a synthesis. He also remarked that he is aware that this project was ranked last year and is part of the Master Schedule, but is unclear on how CMER decides what projects are approved when funds become available.

Hicks moved to approve the request, Kay seconded, Martin opposed – **non-approval** Martin requested a revision to add another question to include restoration of riparian function after fire. Mendoza replied that he didn't think this was fair to SAGE, as UPSAG and WetSAG didn't go through a similar process. Baldwin replied that he didn't understand what Martin was requesting and he would prefer that it is just voted down. He would like Martin to work with WFPA members of SAGE to get his concerns addressed so this can get completed at the next SAGE meeting.

Mendoza moved that CMER approve SAGE request to go to Policy for approval funds, contingent upon further review of SAGE and CMER consistent with their approval process outlined in the CMER PSM. Kroll seconded. - **Approved**

UPSAG

Hooks gave the background on the UPSAG request. Berge replied that this request didn't need CMER approval but asked CMER how they would like this presented to Policy. Mendoza said he felt it should come from the CMER Co-Chairs.
