About fpOnline


- Modernizes creation, submission, and review process of forest practices applications (FPAs) and water type modification forms (WTMFs).
 - Users will complete and submit forms online, sign electronically, pay online payment, create maps online, and attach PDF or TIFF maps.
 - Meets <u>regulatory</u> requirements, complies with forest practices <u>rules</u>, and adheres to DNR Forest Practices Program <u>policies</u>.
- Cloud-based software solution




About fpOnline

- Allows forest practices region office and field staff to provide more assistance to forest landowners with their forms or in the field.
- Customer-focused approach to make it easier to submit applications, pay fees, and track application status.
- DNR is seeking to fund fpOnline solely through State General Fund dollars.
- · A third-party bank will retain and secure all account information.
- DNR will NOT host or request any banking account or personal identification information.
