Chair welcomed members and guests. Review and approved agenda and last 12 meetings minutes. 13 Minutes Approved: Motion to approve agenda. Juli moved and David Miller seconded motion. 14 Unanimous approval. Motion to approve minutes from November 3rd, 2020. Juli moved and Angel 15 seconded motion. Unanimous approval. 16 **Q&A for program update:** Ben was available to answer questions from the council. Lisa had a question 17 about the statewide workshop, Ben explained that attendance was strong but was surprised that there 18 were so few questions at the end of the workshop. The information from the workshop was highlighted 19 in the TreeLink Newsletter beforehand. There were requests for technical assists and for more info 20 about the vacancies on the WCFC. The breakout rooms ended up being smaller than planned at the end of the meeting, but there was still good conversation. Kathleen Wolf attended and thought that the 21 22 workshop was a good overview, and would encourage another meeting like it held in approximately 6 23 months. Kathleen thanked Juli and Ben for their work on the workshop. 24 Ben explained that the DNR hosted statewide stakeholder meetings at larger events in the past, 25 but the program hadn't done a workshop quite so comprehensive before. Juli mentioned that 26 presenting to an online audience was a bit difficult due to the inability to see the constituents. Ian 27 mentioned that the presentation from Snoqualmie was slick and very good, but the breakout rooms 28 could be a bit challenging to get people talking. Kathleen noted that the depth of what we do now, 29 urban forestry, is more elaborate than in the past (equity grants, legislative agenda, etc. compared to 30 just tree planting). It was pointed out that there is a richness in the conversation now. Cindy mentioned 31 how different urban forestry legislation is similar and are relative, so easier to comprehend and digest. 32 Ben mentioned that since the pandemic, community engagement with the UCF program has been 33 reduced, so the program is reaching out more to communities to see how we can be of assistance in the 34 current environment. Ben gave an update regarding UCF grants. DNR UCF staff and Ian Gray reviewed

grant applications. Grantees were recently contacted by phone. Community Forestry Assistance

1 grantees were discussed and their projects explained. Environmental Justice grantees were discussed 2 and projects were explained. 3 Q&A for ECA and other Legislation: Ben stated that the ECA has been referred to appropriations. Vote 4 on the fiscal amount, determine funding level and mechanism. Ben explained that the DNR requested 5 more funding for staff to compliment the increased work that will come with the ECA. Kathleen 6 mentioned that the first hearing for the ECA wasn't a unanimous vote, but a split vote, so she 7 mentioned the importance of advocacy for the bill. Ben expounded on the politics of those who voted 8 for and against the bill, explaining that those who voted against were for utilizing the funding for Small 9 Forest Landowner assistance instead of the ECA, not that the ECA is a bad bill unto itself. 10 11 **5 Minute Break for council** 12 13 Council elections: Elect 2021 Chair/Vice Chair. Confusion by

- 1 Representatives that thought this bill was in relation to Small Forest Landowners. Clarification for those
- 2 folks. Bill currently in Appropriations, then it will go to Rules. More to come, hopefully next week.
- 3 Kathleen asked what might be the timing or opportunities for external voices to weigh in support of the
- 4 bill, and there seems to be confusion with the WFFA in regards to Small Forest Landowners, how is that
- 5 kind of misinformation countered?
- 6 Julie answered, anyone can weigh in during a public meeting. DNR had a phone call with WFFA after the
- 7 meeting, continuing to have conversations assuring legislatures how this bill can be a win-win for
- 8 everyone.
- 9 Kathleen asked about the funding opportunity for the ECA? Julie mentioned that there is a current
- 10 strange financial situation with the pandemic and recession, but there is hope for funding for the bill due
- to how much support there is. There is agency confidence from the fact that the bill is already in the
- 12 Governor's budget.

- district position on the council (WACD); working with program to create MOU's; engaging with schools
- 20 through healthy youth survey; connect environmental and sustainability education coordinator with
- 21 UCF. Connect through Project Wild.

- 23 people.
- 24 Discussion of findings from each of the groups. Ben, Semra, and John will compile findings into a more
- refined package for the council to review in a future meeting to create a work plan for the year.
