# FPA Reviewer Notification

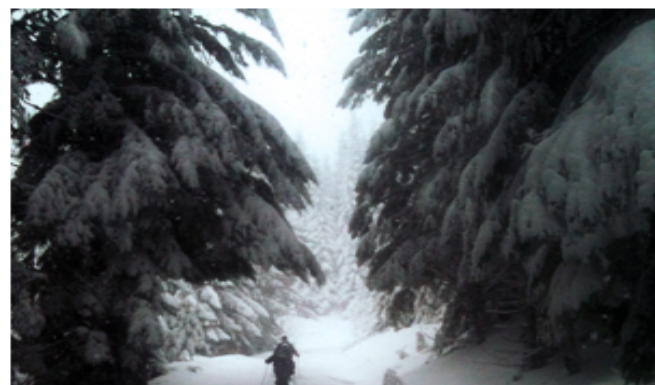

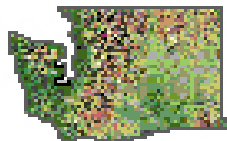
