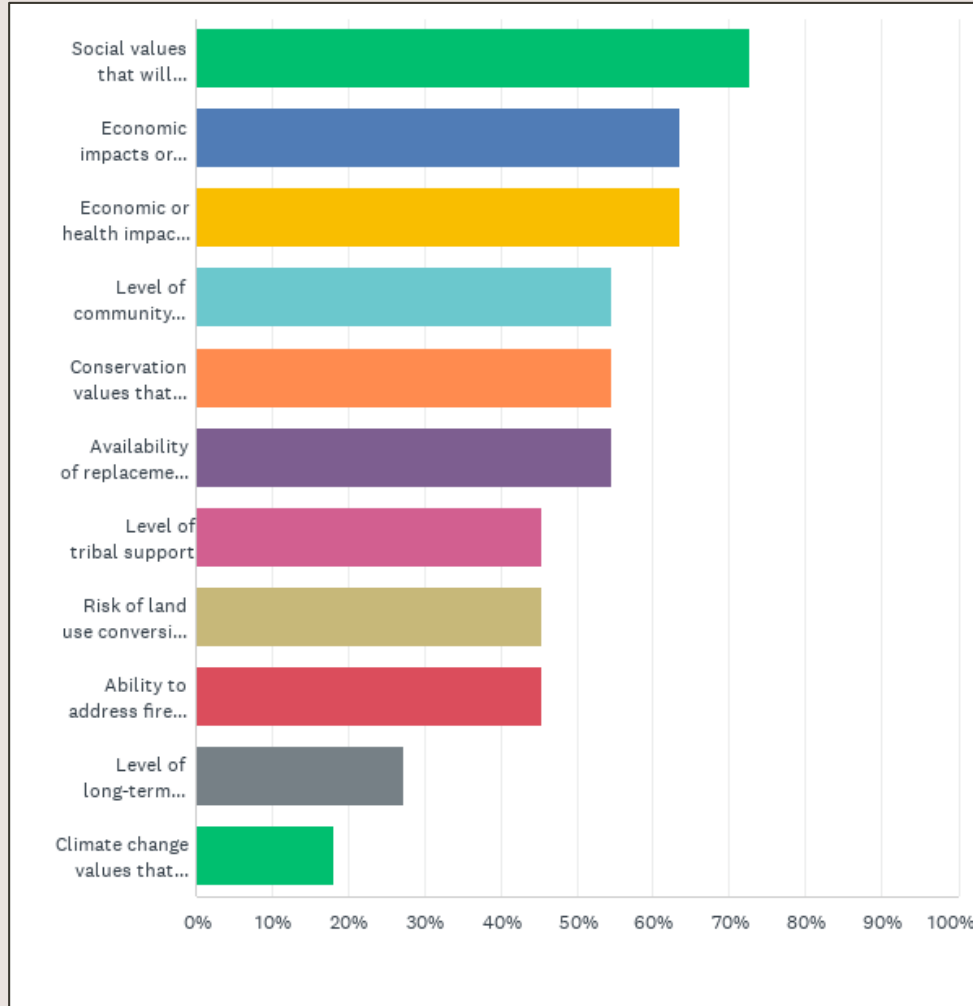

Level of community support	54.55%	6
Conservation values that will continue such as uniqueness of fish and wildlife habitat, or inclusion in a landscape-level conservation plan, once the parcel is transferred	54.55%	6
Availability of replacement lands	54.55%	6

Survey Monkey Results

Comments Summaries



- Primary reasons for TLT is that the lands have higher social or conservation value than revenue potential.
- Social and conservation values should be weighted higher than other criteria and the rest should have equal weight as they are all important to certain constituencies.
- Important to put forth projects that are politically popular with high community support.
- Need to understand the economic impacts to junior taxing districts from the transfer.
- Availability of replacement land should be considered at another step in the process and not as a prioritization criteria, as it is likely much of that information will not be available or known for reviewers.
- Will the transfer help DNR manage the properties more efficiently? What will benefit from the transfer, be specific, so a review could be done in the future.
- Impact to beneficiaries must be considered, including any benefits to beneficiaries by transferring out of trust status.
- Include information about how the parcel contributes to larger recreational or landscape scale projects.
