

Information Provided for Each Parcel*




Packets emailed to you contain:

- Map
- Region application
 - Primary source of information
- Best interests of the trusts analysis
 - Includes information on ecological values and public benefits
- Additional information (type varies from one parcel to the next)
- *Chelatchie Trail has been removed from the list

- Final scores and comment document (Word)

- * Wording of criteria may differ from region applications



How to Determine Score



- 1. Read the packets for each parcel.
- 2. Consult the prioritization criteria tables in the final prioritization criteria document to determine the point range for each criteria.

Point Range: 0-5	Multiplier: 2
0 points	No local communities identified or impacted; or no evidence of community involvement and
	support; or community opposition to this proposed transfer
1-2 points	Minimal community involvement and support
3-4 points	Moderate community involvement and support
5 points	Exceptional community involvement and support

3. Determine the appropriate score.

How to Enter and Tally Scores

- Documents linked to applications ok to reference


