

Budget Proviso Objectives

- I. Collaborate on approaches related to:
 - a. Conservation and management of older, carbon dense, structurally complex forest stands located on DNR-managed lands;
 - b. Increasing carbon sequestration and storage in forests and harvested wood products from DNR-managed forestlands;
 - c. Generating predictable beneficiary revenue;
 - d. Maintaining timber supplies that support local industry; and
 - e. Addressing economic needs in rural counties.





Budget Proviso Objectives (cont.)

- II. Develop an understanding of current timber supply by region and the effect of potential changes to forest management practices on regional wood supply for the timber market;
- III. Explore concepts and strategies relevant to the **sequestration and storage of carbon** in forests and wood products from forested state trust lands managed by DNR.






Work Group Objectives

Goal 3: Generate predictable beneficiary revenue

- Consistent revenue
 - Ensure consistency in revenue streams that are resilient to a changing climate.
- Demand on forests
 - Understand predictable need, increasing costs, growing beneficiary needs, and harvest demand.
- Stakeholder interests
 - Understand the recipient landscape; consider input from stakeholders not present





Goal 4: Maintain timber supplies that support local industry

- Forest management
 - Consider ideas like longer rotations, forest health thinnings, or selective harvest
- Local industry
 - Consider the impacts of leakage from shifting production location; define local industry.
- Economics of forest management
 - Economics of forest management as it relates to jobs, housing, and other social impacts.





Goal 5: Address economic needs in rural communities

- Community stability
 - Improve diversification and reliability to sustain resource-producing communities and economies.
- Market opportunities
 - Learn more about emerging market opportunities, such as carbon markets and improved forest management.


