Investing in Forest Stands

Fiscal Year 2013



- Webster Nursery
 - Shipped 5.7 million seedlings to regions for reforestation trust lands
 - Sold 1.5 million seedlings to the public, valued at \$537k
 - Transplanted 1 million small container seedlings to grow larger seedlings

Investing in Forest Stands

Cont.

Fiscal Year 2013

- **Silvicultural Activities**
 - Planting and vegetation management fully funded for 11-13 biennium
 - Pre-commercial thinning activities resumed in FY 13
- **Genetic Resources**
 - Collected 1500 bushels of cones from DNR seed orchards and the woods
 - Completed measurement of 10 genetics test sites that will guide the establishment of future seed orchard blocks

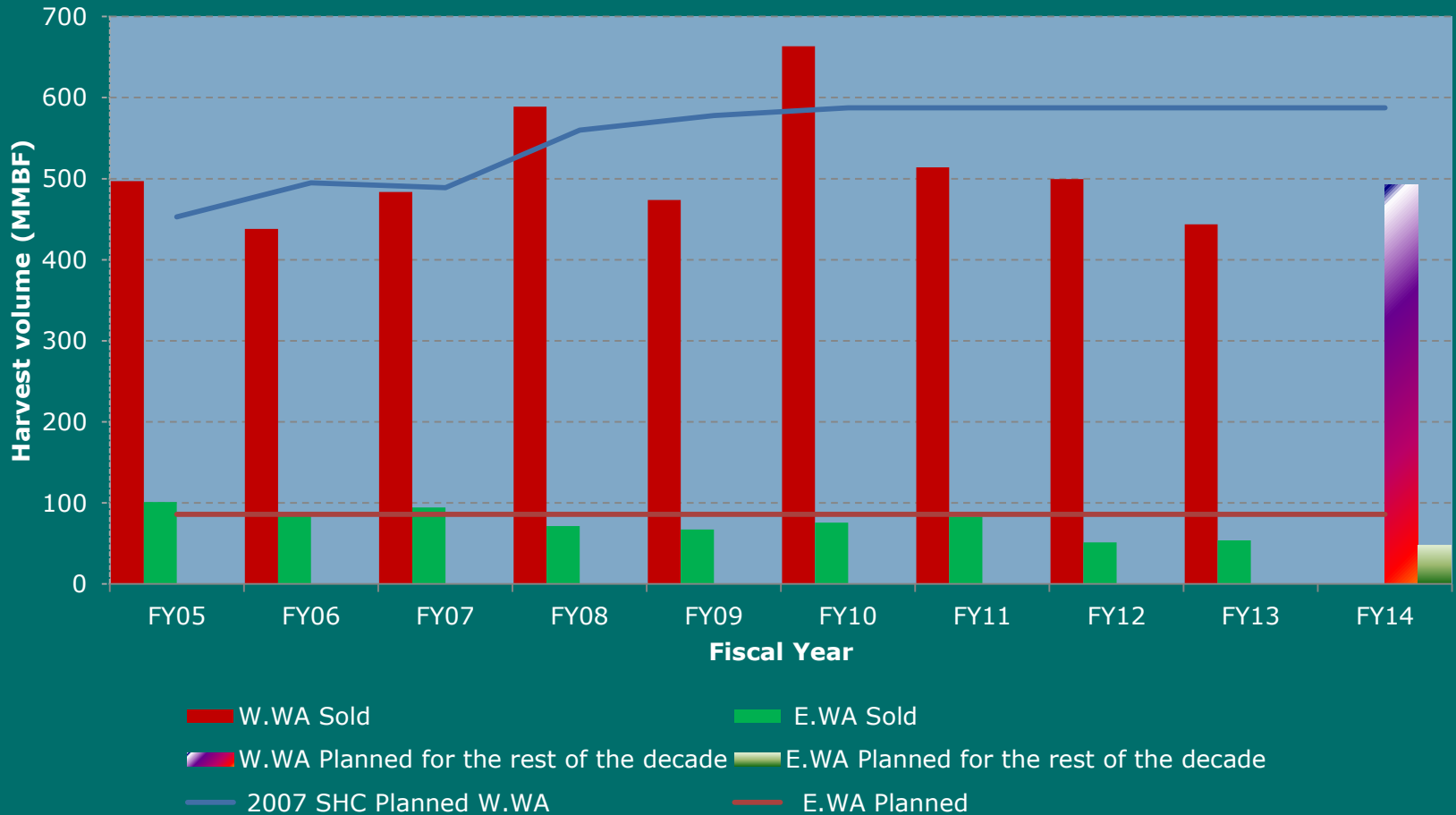

FY05-FY13 Sold Sales + Projected Sustainable Harvest Targets to End of Planning Decade



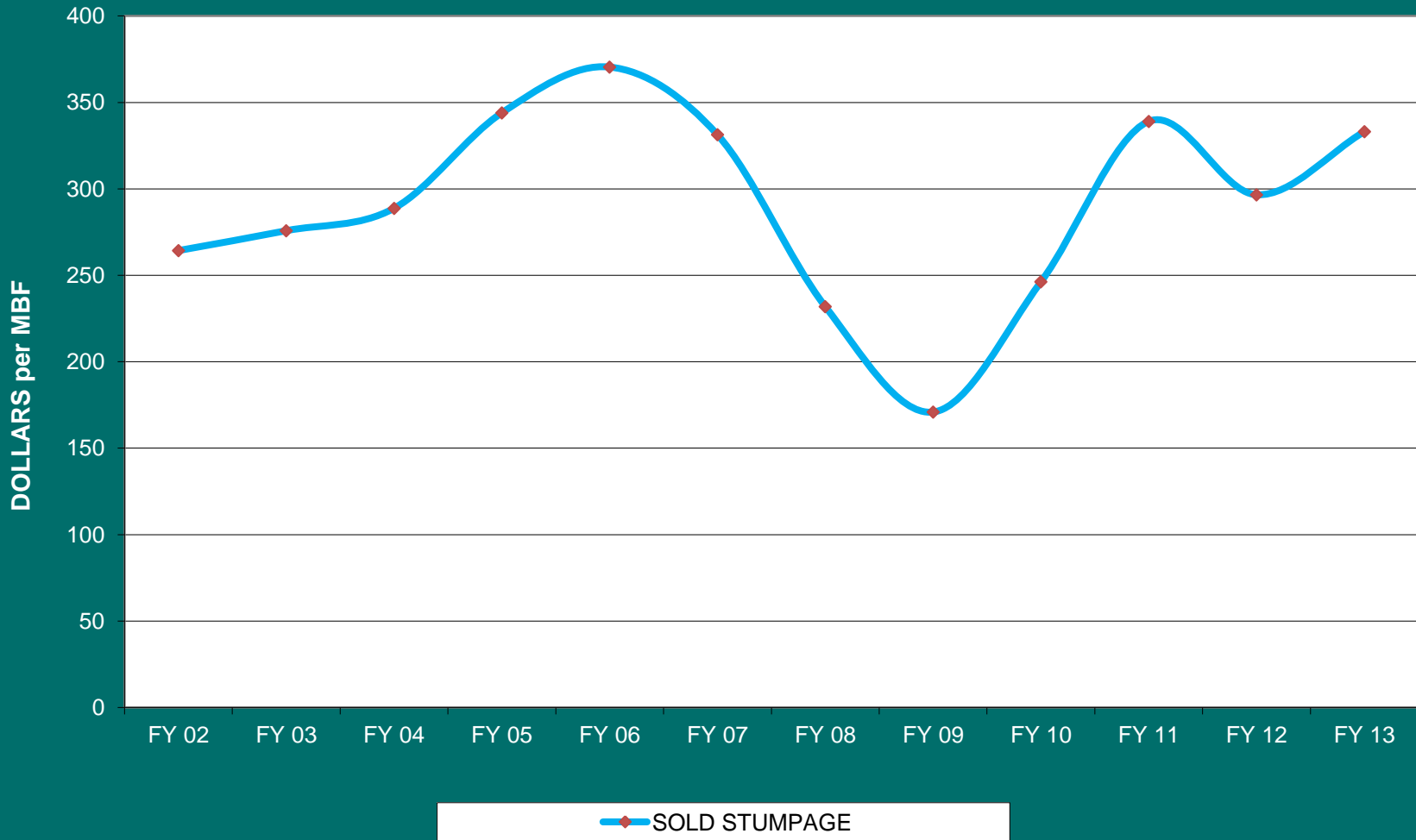

FY05-FY13 Sold Sales and Percent of Projected Sustainable Harvest

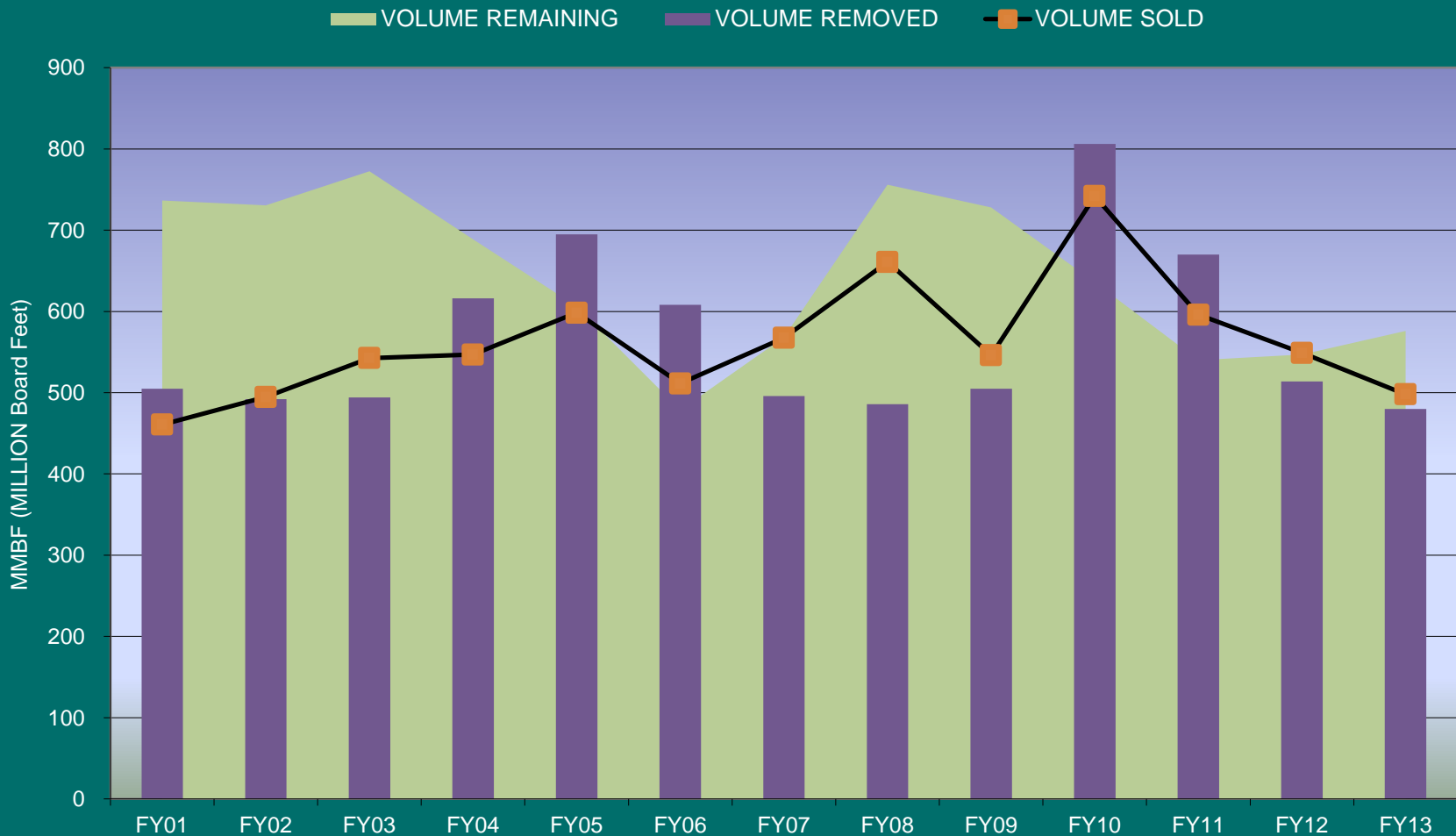

Volume: Sold, Removed, Remaining FY01-FY13



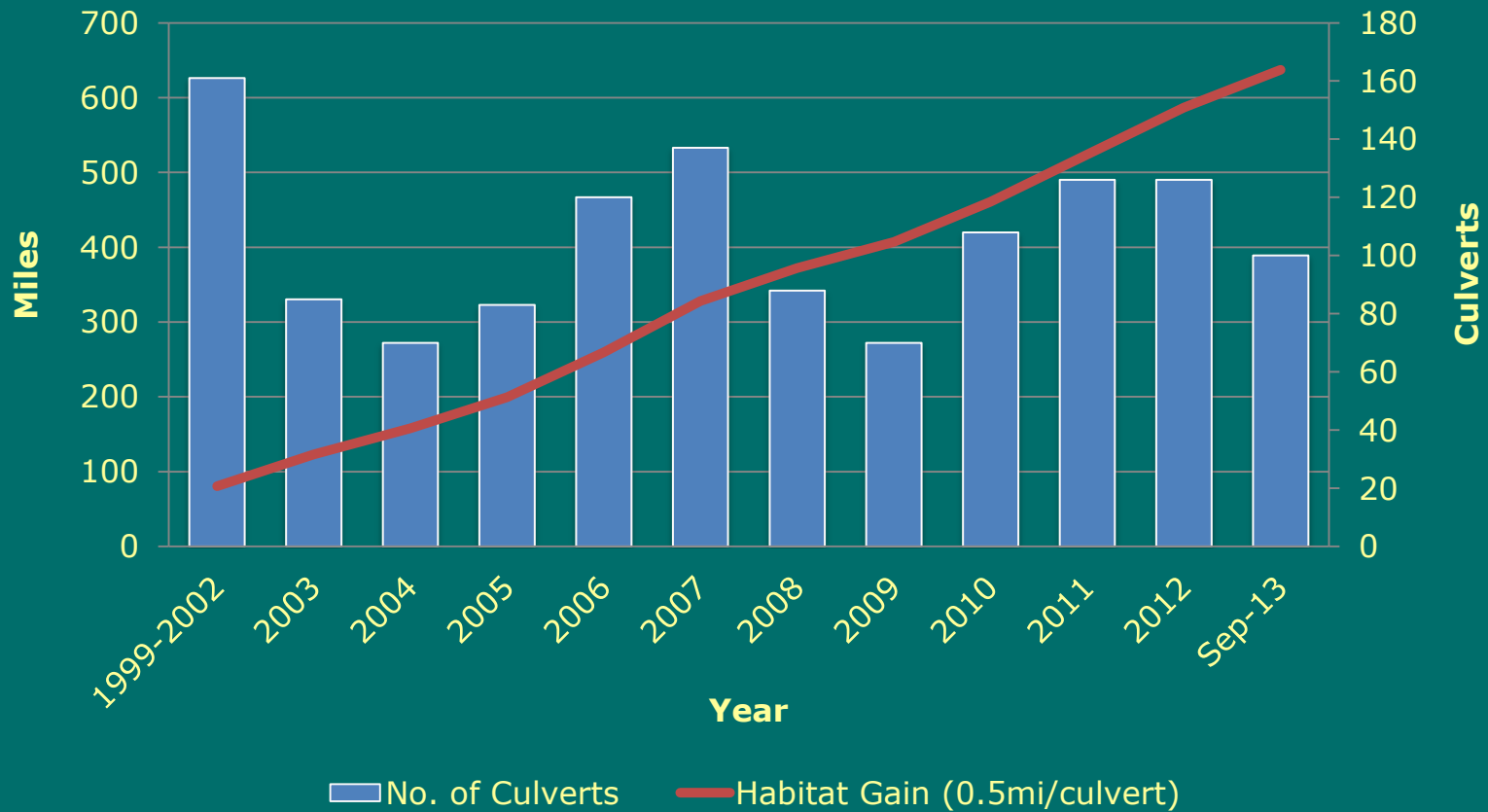
Planning Efforts

- **Olympic Experimental State Forest (OESF) HCP Planning Unit**
 - Revised Draft EIS published October 31st 2013
 - Second year monitoring of riparian sites completed as part of the Status and Trends research project being conducted in collaboration with USFS PNW Research Station
- **Marbled Murrelet Conservation Strategy**
 - Held four public meetings for Phase 2 scoping.
 - Received public comment on conceptual alternatives.
 - Developing alternatives with USFWS for the DEIS.
- **2014 Sustainable Harvest Calculation**
 - Updating data and forest models
 - Reviewing appropriate SEPA process

Transactions Highlights

Fiscal Year 2013

- 811 acres of forest land acquired for trusts
- 865 acres transferred or sold
 - 783 acres for conservation
 - 82 acres to private and other govt
- Implemented State Forest Trust Replacement Program
 - 147 acres in two counties to NRCA
 - \$1,005,670 payment of timber value to counties
 - \$61,000 for land replacement
