

Purpose of checklist



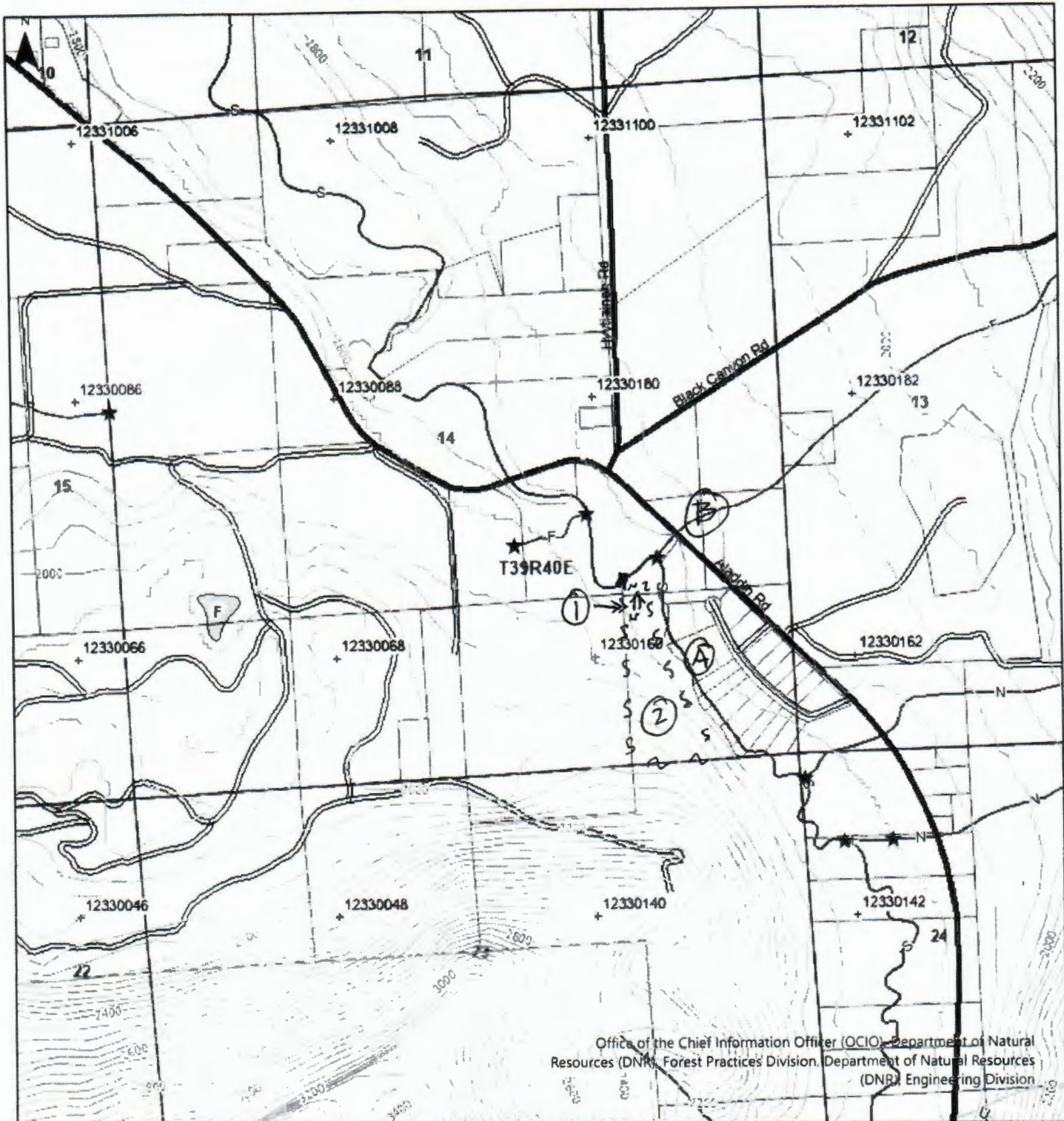
