**DNR is currently intending to negotiate a ground lease with a developer. Lease negotiations are anticipated to occur within 2024-25 with potential development activity occurring as early as 2025-26.**

**DNR's current plans are solely to negotiate a ground lease for commercial development. Future development of the site by the lessee may require additional SEPA review at the time of development.**

***The city of Liberty Lake has more established parks within its city limits. Orchard Park is the closest park to this property and is approximately 1 mile to the west. In addition, the site is within a mile of several golf courses, a community garden and the town center.***

#### 13. Historic and cultural preservation

***No buildings, structures, or sites have been previously documented within the subject parcel.***

***Seven archaeological sites and one historic building are located within one mile of the subject parcel. A historic railroad property, site 45SP903 (1903 Spokane Inland Empire Electric Line Railbed Segment) is eligible for the NRHP under Criterion A. Site 45SP903 is also the site that is closest of these eight documented cultural resources to the subject parcel at 145 meters to the north of the north edge of the parcel. The historic records of the 1903 Spokane Inland Empire Electric Line Railbed alignment and DNR tract book indicate that no portion of the railroad was built within the subject parcel.***

- b. Are there any landmarks, features, or other evidence of Indian or historic use or occupation? This may include human burials or old cemeteries. Are there any material evidence, artifacts, or areas of cultural importance on or near the site? Please list any professional studies conducted at the site to identify such resources.

***DNR completed a cultural resource investigation for this SEPA review. The investigation is filed under DAHP Project Number: 2024-09-06465 completed by Christopher Noll and is identified as Cultural Resource Survey for the Liberty Lake Commercial Development Land Lease, Spokane***

**County, Washington. Report completed by the Washington State Department of Natural Resources, Olympia, Washington (Noll 2024).**

**The subject parcel is flat centrally located portion of a large plain. No surface water sources are located within the parcel and no distinct concentrations of floral or faunal resources are present, though the local environment is home to large and small game animals and plant resource types that were used by Indigenous people in the past. Historic records indicate that the area was subject to agricultural uses, transportation infrastructure development, and recent commercial development. Nearby documented archaeological and historical sites include three precontact sites, a historic farmstead, two historic agriculture-related features, a historic railroad property, and a historic residence. The parcel includes a natural gas transmission line, a highway right-of-way, and local road rights-of-way. The cultural resource survey for the Liberty Lake Commercial Development Land Lease did not identify cultural materials within the proposed lease boundary (Noll 2024). Archaeological survey of the project area that included pedestrian transects across the entire parcel and shovel test pits distributed throughout the parcel revealed disturbed, very gravelly, soil but no artifacts or features.**

**Prior to the investigation by Noll (2024) the parcel had not been fully subject to an archaeological or historical study. However, four transportation-related projects had been completed along the perimeter of the subject parcel. None of the previously completed projects identified cultural resources in proximity to the subject parcel.**

- c. Describe the methods used to assess the potential impacts to cultural and historic resources on or near the project site. Examples include consultation with tribes and the department of archeology and historic preservation, archaeological surveys, historic maps, GIS data, etc.

**Background Review: Department of Natural Resources State Lands Archaeologist for the Northeast Region, Christopher Noll, completed a desktop file review of documents that are relevant to the subject parcel. The sources reviewed are the Washington Information System for Architectural and Archaeological Records Data (WISAARD) maintained by the Department of Archaeology and Historic Preservation (DAHP); General Land Office (GLO) 1878 Cadastral Survey Plat of Township 25 North, Range 45 East, Willamette Meridian and associated survey notes; U.S. Geological Survey topographic quadrangles Liberty Lake, WA-ID (1973, 1:24,000 Scale, 7.5-Minute Series) and Greenacres, WA-ID (1949, 1:62,500 Scale, 15-Minute Series); historical atlases Fidelity Abstract Company's 1904 Township Maps of Spokane County, Washington, George A. Ogle and Company's 1912 Standard Atlas of Spokane County, Washington, and Metsker's 1950 Atlas of Spokane County, Washington; DNR tract book records; the Natural Resources Conservation Service Soil Survey of Spokane County, Washington; and environmental data published by the Environmental Protection Agency, U.S. Geological Survey, U.S. Forest Service, and academic publishers. Each of the sources noted above was searched for indications of cultural features or resources that could indicate the presence of archaeological and/or historical sites.**

**Tribal Consultation: On September 6, a project and preliminary background summary along with a location map were sent via email to Jill Wagner, Coeur d'Alene Tribe; Guy Moura and Rebecca Gordon, Colville Confederated Tribes; Kevin Lyons, Kalispel Tribe; and Randy Abrahamson, Spokane Tribe of Indians. No tribes responded with concerns regarding this specific location.**

**Field Investigation: An archaeological survey consisting of pedestrian survey and shovel test pit excavation was completed by DNR.**

- d. Proposed measures to avoid, minimize, or compensate for loss, changes to, and disturbance to resources. Please include plans for the above and any permits that may be required.....

**The present project action is a lease agreement, and as such will not result in immediate ground disturbing activity. No cultural resources are present within the parcel that may be impacted by current or future development activity. Despite the area having a high risk for containing cultural resources according to DAHP's archaeological predictive model the survey of the lease parcel found that no cultural materials are present. The proposed lease and any subsequent development of the Liberty Lake parcel will not impact cultural resources. The lease and development can proceed with no further cultural resource investigations.**

#### 14. Transportation

**The site is directly adjacent to E. Mission Avenue and E. George Gee Avenue.**

- b. Is the site or affected geographic area currently served by public transit? If so, generally describe. If not, what is the approximate distance to the nearest transit stop?

**The site is not served by public transit. The closest bus stop is Mullen Rd at Tri-Lake Dr. Bus Route 67 approximately 1 mile from the site.**

- c. Will the proposal require any new or improvements to existing roads, streets, pedestrian, bicycle or state transportation facilities, not including driveways? If so, generally describe (indicate whether public or private).

**The ground lease phase will not require any new roads or improvements to existing roads.**

- d. Will the project or proposal use (or occur in the immediate vicinity of) water, rail, or air transportation? If so, generally describe.

**There is no water, rail, or air transportation in the immediate vicinity.**

- e. How many vehicular trips per day would be generated by the completed project or proposal? **The initial ground lease phase will not generate any additional vehicular trips per day.**

**The initial ground lease phase will not impact movement of agricultural and forest products.**

- g. Proposed measures to reduce or control transportation impacts, if any:

**There is no transportation impact from the initial ground lease phase.**

***The initial ground lease phase would not impact public services. Future development phases would add commercial activity to the site, however, the City of Liberty Lake has zoned this property Freeway Commercial with the anticipation and need for commercial development at this location. Depending on the development, there may be minor increased demand for public services.***

- b. Proposed measures to reduce or control direct impacts on public services, if any.

***Not applicable for the ground lease. Future ground lessees would be taxed at the 12.84% leasehold excise tax rate which contributes to funding these public services.***

***None known at this time. Future development will be required to utilize local utility providers.***

***The ground lease phase does not have utilities or general construction activities. Future development will be required to hook up to the City of Liberty Lake's sewer and water systems and utilize existing providers for electricity, phone/internet, and refuse.***
