This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

**Portrait Timber Sale #106261 and Forest Practice Application #3026986 is a sale of approximately 3,000 MBF of timber on 351 acres. The proposal includes 7,322 feet of road construction, 1,839 feet of road abandonment and 31,247 feet of road maintenance. Located in Section 12, Township 38 North, Range 23 East, and Sections 05, 06, 07, 08, 18, Township 38 North, Range 24 East, W.M., Okanogan County.**
