Rose Hill Timber Sale #108041 and Forest Practice Application #3027494 is for the sale of approximately 5,259 MBF of timber from 374 acres. The proposal includes 4,014 feet of road construction, and 25,897 feet of road maintenance. Located in Section 04, Township 29 North, Range 39 East, and Section 34, Township 30 North, Range 39 East, W. M., Stevens County.
