Forest Practice Application #2618467/#2618469 proposal is for approximately 0.7 acres of right of way harvest within 2 harvest units, removing approximately 14 MBF. The proposal includes approximately 1,350 feet of road construction and approximately 250 cubic yards of spoils. Located in Section 04, Township 27 North, Range 12 West, W.M., Jefferson County.
