SUBJECT: SEPA LEAD AGENCY & DETERMINATION OF NONSIGNIFICANCE

This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Parched Timber Sale #102017 and Forest Practice Application #2617912 proposal consists of five variable retention harvest units with associated rights-of-way, encompassing approximately 242 gross acres and a net harvest area of 192 acres, with an estimated sale volume of 7,393 MBF. The proposal includes approximately 10,283 feet of new road construction, 2,075 feet of road reconstruction and 50,077 feet of pre-haul maintenance have been proposed to meet access needs into sale area. Rock sources will be Place Pit, Dry Hill Pit, or commercial sources. This proposal also includes a culvert replacement and slope buttressing plan to stabilize a shallow slide that occurred over the PA-H-3100 road. Located in Sections 13, 14, 22, 23, 24, 25, 26, Township 30 North, Range 07 West, Section 19, Township 30 North, Range 06 West, Section 33, Township 31 North, Range 07 West, W.M., Clallam County.
