This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

**Forest Practice Application #2942631 proposal consists of 41 acres of even-aged timber harvest, fiber recovery, and salvage, removing approximately 1,193 MBF and 150 tons. The proposal includes 999 feet of road abandonment. Proposals for future activities related to this site may require additional SEPA review. Located in Section 16, Township 11 North, Range 05 West, W.M., Lewis County.**
