Forest Practice Application #2942647 proposal consists of 46 acres of even-aged timber harvest, removing approximately 1,660 MBF and 100 tons. The proposal includes 700 feet of road construction. Proposals for future activities related to this site may require additional SEPA review. Located in Section 34, Township 12 North, Range 06 East, W.M., Lewis County.
