This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Action Item Sorts Timber Sale #105538 and Forest Practice Application #2942411 proposal is for a variable retention harvest with approximately 102 acres in 3 units, removing approximately 4,835 MBF of timber. The proposal includes 2,185 feet of road construction, 500 feet of road reconstruction, and 4,110 feet of pre-haul maintenance. Located in Sections 17, 18, 19, 20, Township 13 North, Range 05 West, W.M., Lewis County.
