This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Amoeba Timber Sale #106098 and Forest Practice Application #2943013 proposal is a variable retention harvest with 99 acres in one unit and 15 acres of right of way harvest in one unit, for a total of 114 acres in two units, removing approximately 5,309 MBF of timber. The proposal includes 13,188 feet of road construction, 1,871 feet of road reconstruction, and 28,660 feet of pre-haul maintenance. Located in Sections 14, 15, 17, 22, Township 11 North, Range 09 West, W.M., Pacific County.
