This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

**Auger In Timber Sale #107774 and Forest Practice Application #2942951 proposal is a variable retention harvest with 64 acres in two units, removing approximately 2,584 MBF of timber. The proposal includes 2,594 feet of road construction and 27,945 feet of pre-haul maintenance. Located in Sections 27, 34, 35, Township 13 North, Range 06 West, W.M., Pacific County.**
