This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Four Score Timber Sale #107096 and Forest Practice Application #2942785 proposal is for a variable retention harvest with approximately 84.2 acres in 2 units, removing approximately 4,039 MBF of timber. The proposal includes 3,544 feet of road construction, 1,478 feet of road reconstruction, 51,048 feet of pre-haul maintenance, and 1,400 feet of road abandonment. Located in Sections 09, 10, 15, 16, Township 14 North, Range 05 West, W.M., Lewis County.
