SUBJECT: **SEPA LEAD AGENCY & DETERMINATION OF NONSIGNIFICANCE**

This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Shady Grove VDT Timber Sale #106097 and Forest Practice Application #2942413 proposal is a variable density thinning with 146.1 acres in 4 units and 9.6 acres of right of way harvest in 7 units, for a total of 155.7 acres in 11 units, removing approximately 4,257 MBF of timber. The proposal includes 3,514 feet of road construction, 2,096 feet of road reconstruction, 29,694 feet of pre-haul maintenance, and 5,440 feet of road abandonment. Located in Sections 13, 24, Township 03 North, Range 7.5 East, Section 13, Township 03 North, Range 7 East, and Sections 18, 19, Township 03 North, Range 08 East, W.M., Skamania County.
