This is to advise you that pursuant to WAC 197-11-900 (922 through 948), the Department of Natural Resources has determined that it is Lead Agency for the following:

Brewed Awakening Timber Sale #104865 and Forest Practice Application #2424167 proposal is for approximately 143 acres of even-aged harvest and 50 acres of uneven-aged harvest with an estimated 4,510 MBF of timber being removed, utilizing ground and cable based harvesting methods. The proposal includes a 0.1-acre rock pit. Forest Practices rule-identified unstable landforms are located adjacent to and within the proposed project area. Located in Sections 13, 24, 25, Township 23 North, Range 07 East, and Sections 19, 30, Township 23 North, Range 08 East, W.M., King County.
