FPA 2424218 indicates 119 acres of uneven-age harvest, 10.5 acres of even-age harvest, and 1 acre of new rock pit.

Proposed uneven-aged harvest of 119 ac and proposed even-aged harvest of 10.5 ac. Uneven-aged harvest is part of a commercial thinning program intended to promote forest growth. Even-aged harvest area will be replanted following harvest.

FPA 2424218 includes 440 feet of road construction, and 27.4 acres of thinning on 4 rule identified landforms.


