

NOTICE OF INTENT TO OBTAIN EMERGENCY CUSTODY

VESSEL with Registration # 2024 WN 5419 W

San Juan County declared the vessel **WN 5419 W** an emergency because it meets the criteria for temporary possession described under RCW 79.100.040(3). San Juan County took temporary possession of the sunken vessel and had it refloated, removed and hauled out at the Port of Friday Harbor from **Beaverton Cove 48 32.625 123 00.951** in order to prevent it from further breaking up, blocking navigation, or posing a threat to human health and safety or the environment.

San Juan County intends to take formal and full custody of the vessel on **December 30, 2024.** After taking custody, San Juan County may use or dispose of it without further notice. The owner is responsible for all related costs.

In order to keep the vessel, the owner must take the following actions before the Custody Date:

- Pay San Juan County back for costs incurred to date, and
- Move the vessel to an approved storage location <u>out of the water</u> that authorizes the vessel.

If the owner wants to reclaim the vessel after San Juan County has custody or wants to challenge San Juan County's decision to take custody, the owner must file a written appeal with the Pollution Control Hearings Board (PCHB) and serve a copy on San Juan County. Addresses are in the boxes below:

The appeal must include the following information:

- A copy of this notice or a copy of the notification letter to the owner.
- Your name and address (mailing and legal, if different) and, if applicable, the name and address of your representative.
- A daytime phone number.
- A brief statement of why you are appealing.
- A statement of what you want the Pollution Control Hearings Board to do.
- Your signature or that of your representative. This signature certifies that the content of the appeal is true.

The owner may submit the appeal immediately, but the PCHB must receive it no later than **January 30, 2025**. The owner waives the right to a hearing if the PCHB does not receive an appeal on or before the Appeal Date. The owner is then liable for any costs incurred by San Juan Conty in responding to the vessel. These costs may include all administrative costs incurred by San Juan County, removal and disposal costs, and costs associated with environmental damages directly or indirectly caused by the vessel. If there is a lawsuit, the successful party may receive reasonable attorneys' fees and costs.

San Juan County also may pursue any other remedies available under law. San Juan County is taking this action under the authority of Chapter 79.100 RCW.
