

  - Users will complete and submit forms online, sign electronically, pay online payment, create maps online, and attach PDF or TIFF maps.
  - Meets <u>regulatory</u> requirements, complies with forest practices <u>rules</u>, and adheres to DNR Forest Practices Program <u>policies</u>.







#### Funding


Washington state has fully funded fpOnline for fiscal year 2025.
