### Additional Terms and Conditions

1. **Each permittee** must possess a valid permit when harvesting, processing or transporting the special forest products on the permit.
2. **Only one (1) person per permit.**
3. This permit is valid **only** for the product and dates indicated on the permit.
4. The products may be removed only in the location indicated on the permit and attached map(s). Permittee is responsible for determining harvest area boundaries and legal access to harvest area.
5. The colored vehicle permit card must be displayed in windshield of the vehicle during harvest and/or while transporting products.
6. All harvest debris must be removed from roads and ditches and scattered throughout the forest. **All garbage generated by permittee must be removed from state land.**
7. Permittee will do all in their power to prevent forest fires. No fires are allowed outside designated campgrounds.
8. No camping is allowed outside designated campgrounds. Approved campsites have a seven (7) day stay limit. Some DNR campgrounds may be closed during the winter.
9. This permit does not guarantee the quality or quantity of product purchased.
10. Permittee will harvest products using acceptable harvest practices. Rakes and any ground disturbing devices are not allowed. Permittee will not harvest in a manner that causes undo damage to the resources and/or associated ecological values. If damage occurs, the state may assess penalties.
11. **No harvest is permitted within 50 feet of any flowing stream, dry stream bed, or body of standing water. No harvest is permitted within 200 feet of a designated DNR campground. No Harvest is permitted behind closed gates or areas with active logging operations.**
12. Law enforcement action will be taken for unauthorized harvest, trespass or littering.
13. This permit is non-refundable/transferrable and is revocable for failure to comply with permit terms and conditions.
14. No motorized vehicles allowed off existing road surfaces or behind closed gates.
15. **All vehicles engaged in any harvest operations are required to have a minimum vehicle liability insurance.**

### Permit Requirements

1. Each Permittee must have a valid form of picture identification  
Any person using a valid Washington State Driver's License for identification must comply with the Motor Vehicle Financial Law, RCW 46.29.630
2. Each Permittee must carry valid Vehicle Registration for the vehicle that will be used during harvest.
3. Each Permittee must have Motor Vehicle Insurance Coverage for the vehicle that will be used during harvest

*Insurance coverage must be for no less than:*

- \$25,000 bodily injury, one person
- \$50,000 bodily injury for two or more persons
- \$10,000 for injury or destruction of property

4. Permit Price: **\$600.00** per person (only 1 person per permit)

**Permits are valid from date of purchase to December 31, 2025.**

St. John's Wort Flower
