## **ACCOMPLISHMENTS**

#### **Software Configuration**

VisualVault completed Sprints 1-3. See below for more updates from VisualVault.

We have completed the baseline survey of DNR's Forest Practices Application (FPA) process. See the results below.

We have selected a new tester and contract review is underway.

#### **UPDATES FROM VISUAL VAULT**

In October, VisualVault accomplished the following toward development of the fpOnline system:

- 1. Defined high level technical architecture
- 2. Continued configuration with further build out of the Forest Practice Application/Notification (FPA/N) form in Sprint 3
- 3. Initiated QA cycles for each sprint
- 4. Conducted VisualVault knowledge transfer interviews
- 5. Developed solutions for Contact Management and Signature functions
- 6. Developed initial versions of the following forms online:
  - FP Aerial Chemical Application Form
  - Step 1 Long-Term FP Application Form Eastern & Western Washington
  - FPA/N Renewal Form
  - FPA/N Amendment Request Form
  - FPA/N Notice of Transfer
  - Long-Term Application 5-Day Notice

VisualVault looks forward to demonstrating the user's experience with fpOnline's new FPA in November's Town Hall.

# **PROJECT MILESTONES & PHASES**

- The Planning phase involves preparation for RFP, team selection and high-level requirements. This phase started in May 2023.
- The PROCUREMENT phase involves request for proposals, technology budget, vendor selection, and contract negotiations. This phase started in November 2023 and ended in July 2024.
- The DISCOVERY phase involves determining detailed requirements and ensuring common understanding. This phase started in July 2024 and ended in September 2024.
- The CONFIGURATION phase involves configuring software to meet requirements. This phase started in July 2024 and ends in February 2025.
- The TESTING & TRAINING phase involves testing configuration and comparing it to requirements and training users using multiple formats. This phase starts in February 2024 and ends in April 2025.
- The software will Go Live in May 2025.

# **QUESTION OF THE MONTH**

#### What is the Training Plan for fpOnline?

fpOnline Training will be custom designed for system administrators, staff, super users, and community users. The training has three certification levels:

#### 1. Fundamental Training Series

For all users; covers basic navigation and functionality of fpOnline, and includes hands-on experience.

#### 2. System Administrator Certification

For admins who will manage system security and user access, and make functional changes.

#### 3. Implementer Certification

Advanced technical training on how to write scripts; manage queries; and create iForms, workflows, analytic data models, and reports.

**Train-The-Trainer Program.** Training will be conducted in each Region by DNR Trainers who have completed VisualVault's Train-The-Trainer Program. DNR Trainers will be selected based on their understanding and interaction with the fpOnline application, and their knowledge of DNR's Forest Practices Program business processes.

**Measuring Effectiveness.** The fpOnline Training Team will formally monitor end-user training sessions. Monitoring supports consistent delivery of the training experience and ensures the feedback provided improves future training events.

The training process will begin in 2025:

- January 2025 Create Role-based Curriculum
- February 2025 Develop Training Materials
- March 2025 Validation, Testing, and Pilot Training
- April 2025 Deploy and Deliver Training
- May 2025 Measure Training Effectiveness

## **Nerd Corner**

#### 2024 Baseline User Experience and Partner Survey

The fpOnline Team conducted a baseline survey to measure the satisfaction that users and partners have with DNR's current FPA process. In future years, we will use this baseline to compare user satisfaction with fpOnline. The table below shows the percentage of people who "agreed" or "strongly agreed" with each statement.
